The closing date for applications is 4pm on 23rd June 2008. Applications received after this date will not be accepted. You may submit payment for the re-sit with the application, however, due to the short space of time between the publication of 2008(1) full results and this closing date, payments will be accepted to follow applications up until 4pm on 30th June. If an application is submitted by 23rd June as required without payment and payment does not follow by 4pm on 30th June you will be withdrawn from the exam.

Candidates may withdraw from the examinations at any time up to twenty four hours prior to exam. The examination fee is non-refundable once received.

The Council publishes information about the pass requirements for the exams. Candidates must satisfy these requirements before being entitled to commence post-examination training.

The Council will post 2008(1) OSPE re-sit results to candidates on 21st July and will publish exam results on 22nd July. Results will only be released to candidates. Candidates that pass the exam will receive a separate letter of declaration of success in compliance with rule 1 (1)(d) of the Standard of Competence (2007).

The Council will only use information provided in this form for the purpose of administering the Council’s examinations. These data will be used by the Council, its appointed examinations contractor and agents and the examination moderator and invigilators.

Completed exam scripts for both the written and practical exams will be kept for a period of two weeks following the publication of the exam results, and will then be destroyed. The Council does not issue individual feedback to candidates, feedback can be gained from the chief examiner’s report and the moderator’s report, both of which are published on the Hearing Aid Council’s website.
