Applications received after this date will not be accepted.

Candidates may withdraw from the examinations at any time up to twenty four hours prior to the theory (written) exam. The examination fee is non-refundable after the closing date given above.

The Council publishes information about the pass requirements for the exams. Candidates must satisfy these requirements before being entitled to commence post-examination training.

The Council will issue results as below:

- Theory (written) results will be posted to candidates on 23<sup>rd</sup> October 2008 and published on the website on the 24<sup>th</sup> October 2008.
- Practical (OSPE) results will be posted to candidates on 20<sup>th</sup> November 2008 and published on the website on the 21<sup>st</sup> November 2008

Results will only be released to candidates. There is no right of appeal. Candidates that pass both parts of the exam will receive a separate letter of declaration of success in compliance with rule 1 (1)(d) of the Standard of Competence (2008).

The Council will only use information provided in this form for the purpose of administering the Council's examinations. These data will be used by the Council, its appointed examinations contractor and agents and the examination moderator and invigilators.

Completed exam scripts for both the written and practical exams will be kept for a period of two weeks following the publication of the exam results, and will then be destroyed. The Council does not issue individual feedback to candidates, feedback can be gained from the chief examiner's report and the moderator's report, both of which are published on the Hearing Aid Council's website.
